Important Information**

- *A homeschool form does not need to be completed for students enrolled in an online public school as identified on the Colorado Department of Education website; www.cde.state.co.us.*
- *Notice of intent to provide a homeschool (home-based) education program is required each school year. Notification must be submitted a minimum of 14 days prior to beginning a homeschool program.*
- *Students with a history of habitual truancy within the last six (6) months of enrollment may be required to submit specific curriculum materials in addition to the Notification of Intent to Homeschool form when requesting to withdraw to homeschool.*
- *Students will not be withdrawn from school to enroll in homeschooling until the notification of intent to homeschool is submitted to and approved by the District's Admissions Office.*
